**Call to Order:** Supervisor Russ Van Dam called the meeting to order at 7:30 pm and Tom Flokstra opened with prayer.

**Members Present:** Russ Van Dam, Pat Reuschel, Renee Hop, Tom Flokstra and Harv Jipping.

**Minutes:** The Feb 10, 2015 Board meeting were read for approval.

**Al Co Commissioner:** Jim Storey gave an update on county activities: Dog loss claims update, Ag Tech- new farm inventions will receive \$14,00 from county with a private sector match, addressing the lack of radio dispatch reception, old jail site will become 80 new parking spaces.

**Al Co Resource Recovery:** Ben Williams gave information for the Hazardous/Electronic recycling event on May 30, 2015 from 9-1 and the Scrap Tire Collection on June 20th, 9am-12 at the township hall.

**Overisel Fire Department:** Chief Ron Horsting reported a total of 12 calls for February.

**Overisel/Fillmore Deputy:** Deputy Retamal reported a total of 76 calls for February, 56 for Fillmore and 20 for Overisel.

**Zoning Report:** Jipping reported the Appeal Board approved a 61' set back for a building at Winding Creek.

**Supervisor:** Van Dam reported that Chef Container prices will increase \$20/box and \$6/ton. People are encourage to fill out the Allegan County Broadband Survey.
