Board of Trustees Monthly Meeting  
8/11/2015

**Call to Order:** Supervisor Russ Van Dam called the meeting to order at 7:30 pm and Pat Reuschel opened with prayer.

**Members Present:** Russ Van Dam, Pat Reuschel, Renee Hop, Tom Flokstra and Harv Jipping.

**Minutes:** The July 14, 2015 Board meeting were read for approval.

**Al Co Commissioner:** Jim Storey gave an update on county activities: Annual State of the county Report is available, dog license will be available from veterinarian offices along with the county, jail demo and parking - \$94,000.

**Road Commissioner:** Bob Kaarlie gave an update on roads, 38th st detour, revised truck ordinance.

**Overisel Fire Department:** Chief Ron Horsting reported a total of 14 calls for July, open house had good turnout. Flokstra reported on the Fire Board meeting - waiting for signature on boundary line changes, cost recovery updates, chairs still bad.

**Overisel/Fillmore Deputy:** Ray Retamal reported a total of 54 calls for July. Fillmore had 34 calls and Overisel had 20 calls.

**Zoning Report:** Appeal Board meeting - Scholten and Volkers both denied variances, Planning Commission meeting next week.

**Supervisor:** Free Dump Day will be Sept 19, 2015. 146th culvert- DEQ permit this week, Frontier possibly adding better internet lines, Road Plan and the Truck Ordinance was discussed.

4. A motion was made by Renee Hop and supported by Pat Reuschel to approve paying the bills. Motion Carried.
5. A motion was made by Pat Reuschel and supported by Harv Jipping that the meeting stand adjourned. Motion Carried.
