Board of Trustees Monthly Meeting  
3/20/2018

**Call to Order:** Supervisor Russ Van Dam called the meeting to order at 7:30 pm and Tom Flokstra opened with prayer.

**Members Present:** Russ Van Dam, Pat Reuschel, Renee Hop, Tom Flokstra and Harv Jipping.

**Minutes:** The Feb 13, 2018 Board meeting were read for approval.

**Al Co Commissioner:** Jim Storey gave an update on county activities: WWI monument dedication- Ganges twp-May 28; MSU-understanding Mi tourism-119 million visitors, outdoor recreation- west side of state; No one in Al Co on the MI dept of treasury for pension/health care is underfunded; New Judge, and New Prosecutor appointed- will be on Nov ballot.

**Road Commissioner:** Bob Kaarli gave an update: Lansing- extra funds- new grater possible; Ash trees still falling; signs- updating as needed; Bike trails- different ideas around the state.

**Overisel Fire Department:** Fire Chief Horsting reported a total of 15 calls for February.

**Overisel/Fillmore Deputy:** Deputy Retamal reported a total of 71 calls for February, 45 for Fillmore and 26 for Overisel; Deputies are visiting all schools to be more visible- office space to do reports; Oct 27 ODC Halloween- one day only in 2018.

**Zoning Report:** Jipping reported there was a planning meeting- Feb 20- R2 and R3- no chickens allowed; trailer needs to be removed on 38<sup>th</sup> by river; Berens needs road(driveway) to house.

**Supervisor:** Van Dam reported new lawyer will be coming to our Wednesday, May 9 (date change because of Zeeland schools election) township meeting; June 16, 2018- electronics/ household hazardous waste recycling- 9am-12pm at Allied/Republic Recycling, 3310 M-40 Hamilton.

3. A motion was made by Renee Hop and supported by Pat Reuschel to approve the budget amendments as presented, adjustments with no increase in budget. Motion Carried.
4. A motion was made by Harv Jipping and supported by Tom Flokstra to approve paying the bills. Motion Carried.
5. A motion was made by Renee Hop and supported by Harv Jipping that the meeting stand adjourned. Motion Carried.
