11/10/2020

**Call to Order:** Clerk Renee Hop called the meeting to order at 7:30 pm and opened with prayer.

**Members Present:** Pat Reuschel, Renee Hop, and Tom Flokstra -virtually from home-Overisel MI, Russ Van Dam and Harv Jipping were absent.

**Al Co Commissioner:** Jim Storey gave an update on county activities: New shelter at Gun Lake; 60% of voters approved the county update to 1965 levels; Chief Haverdink to replace Horsting on 911 board.

**Minutes:** The Oct 13, 2020 Board meeting minutes were read and presented for approval. Motion made by Reuschel and supported by Hop for approval. Motion Carried.

**Overisel Fire Department:** Fire Chief Horsting reported 5 calls for Oct; Flokstra – last weeks fire board meeting discussed- transition of Chief, wishlist needs, openings for more firemen and assistant chief.

**Overisel/Fillmore Deputy:** Deputy Tyler Langrack reported a total of 62 calls for Oct, 46 for Fillmore Twp and 20 for Overisel Twp.

**Supervisor:** Van Dam absent: Ron Horsting retirement open house Dec 1, Tuesday, 6:30-8:30pm at the Overisel station. Thank you Ron for 21 years of service! (postponed due to Covid, no date yet). Township board members were sworn in for the years 2021-2024.

**Motions:**

1. A motion was made by Reuschel and supported by Flokstra to approve compensating Kooienga for his time learning the fire chief position/program with \$2,000. Motion Carried.
2. A motion was made by Reuschel and supported by Flokstra to approve the PA116 of C&M Hog Farms of 34 acres for 20 yrs, part of 03-18-028-003-00. Motion Carried.
3. A motion was made by Hop and supported by Reuschel to approve a work order for 43<sup>rd</sup> st culvert north of 147<sup>th</sup>, replacing existing twin 54” CMP culverts. Motion Carried.
4. A motion was made by Hop and supported by Reuschel to approve a work order for 2021 to repave 144<sup>th</sup> from 42<sup>nd</sup> to 46<sup>th</sup>; 146<sup>th</sup> from 46<sup>th</sup> to 48<sup>th</sup>; 40<sup>th</sup> from 146<sup>th</sup> to 144<sup>th</sup> ave. Motion Carried.
5. A motion was made by Hop and supported by Reuschel to pay the bills as presented. Motion Carried.
6. A motion was made by Flokstra and supported by Reuschel that the meeting stand adjourned. Motion Carried.
