Board of Trustees Monthly Meeting  
4/12/2022

**Call to Order:** Supervisor Russ Van Dam called the meeting to order at 7:30 pm and Reuschel opened with prayer.

**Members Present:** Russ Van Dam, Pat Reuschel, Renee Hop, Tom Flokstra and Harv Jipping.

**Al Co Commissioner:** Jim Storey gave an update on county activities: broadband committee; water study committee-ARPA funds; mental health- move in Feb: more ORV roads.

3. A motion was made by Hop and supported by Reuschel to approve the low asphalt bid from Black Gold Transport for \$804,127 to repave 5.5 miles and 1 mile of new pavement. Motion Carried.
4. A motion was made by Flokstra and supported by Hop to approve the low bid of Toyne for a freightliner 112 SD pump truck for \$460,824. Motion Carried
5. A motion was made by Reuschel and supported by Flokstra to pay the bills as presented. Motion Carried.
6. A motion was made by Jipping and supported by Hop that the meeting stand adjourned. Motion Carried.
