Board of Trustees Monthly Meeting  
2/8/2022

**Call to Order:** Supervisor Russ Van Dam called the meeting to order at 7:30 pm and Hop opened with prayer.

**Members Present:** Russ Van Dam, Pat Reuschel, Renee Hop, Tom Flokstra and Harv Jipping absent.

**Al Co Commissioner:** Jim Storey gave an update on county activities.

**Minutes:** The Jan 11, 2022 Board meeting minutes were read and presented for approval. Motion made by Reuschel and supported by Hop for approval. Motion Carried.

**Overisel Fire Department:** Fire Chief Kooienga reported 12 calls for Jan; fire board – needs list for 2022; SOP's updates going well.

**Overisel/Fillmore Deputy:** Deputy Knaap reported a total of 98 calls for Dec; 72 for Fillmore and 26 for Overisel.

**Zoning Report:** Planning meeting- next week- sand removal permit request.

**Supervisor:.** Budget info was given for next month's budget hearing on March 8, 2022; discussion on 137<sup>th</sup> and mutual aid with Heath Township; need in budget \$5,000 for air bottles, \$16,000 for weekend duty; May 3- Zeeland schools millage renewal on non homestead and a millage renewal for parks and recreation. Starting May 1, 2022 the dump will be open from 8am to 1 pm; a notice will be placed in the newsletter.

**Motions:**

1. A motion was made by Flokstra and supported by Hop to approve the equipment list- of tools and a new AC for 2022 for \$6,250. Motion Carried.
2. A motion was made by Reuschel and supported by Hop to approve the budget amendments as presented, with no net change in the budget. Motion Carried.
3. A motion was made by Hop and supported by Flokstra to approve the salary resolution for the Overisel township board. Motion Carried.
4. A motion was made by Reuschel and supported by Flokstra to approve the work orders: paving 43<sup>rd</sup> st, 137<sup>th</sup> to 142<sup>nd</sup>, 140<sup>th</sup> ave, 43<sup>rd</sup>-38<sup>th</sup>; crack, chip seal 36<sup>th</sup> st, 144<sup>th</sup> to Ottogan share with Salem; paving 37<sup>th</sup>, 139<sup>th</sup> to 140<sup>th</sup>, 141, E. of 40<sup>th</sup>; 139<sup>th</sup>, 38<sup>th</sup> to 36<sup>th</sup>; 138<sup>th</sup>, .42 miles W of 40<sup>th</sup> to 38<sup>th</sup>; 43<sup>rd</sup> st, 142 ave to Ottogan st. Motion Carried.
5. A motion was made by Flokstra and supported by Reuschel to approve the Allegan County Sheriff's Office Law Enforcement Services Agreement and Memorandum of Understanding #1 as presented. Motion Carried.
6. A motion was made by Flokstra and supported by Hop to approve the Professional Services Agreement with Williams & Works to update the zoning book for a cost not to exceed \$27,500. Motion Carried.
7. A motion was made by Reuschel and supported by Flokstra to pay the bills as presented. Motion Carried.
8. A motion was made by Hop and supported by Reuschel that the meeting stand adjourned. Motion Carried.
